

ANNUAL BUSINESS MEETING Tuesday, May 28, 2024

"THE FUTURE OF FACILITIES: ADAPTING TO A CHANGING ENVIRONMENT"

- 1. Meeting Called to Order 8:00 AM: President Kelly Wilson
- 2. Review & Approval of 2023 Annual Meeting Minutes: Greg Adams Secretary Adams noted that meeting draft 2023 annual meeting minutes were published at the GAPPA website and an email sent to Institutional (Voting) Members asking them to review them in advance of this meeting and bring any changes forward at this meeting. Adams called for changes. None were heard. With that, Adams recommended the minutes as drafted to President Wilson for a vote. President Wilson called for a motion to approve. Motion to approve from Bill Moody. Second from David Van Hook. No discussion. Motion carried.

3. Treasurer's Report: Bill Moody

Treasurer Moody noted GAPPA has two components: Foundation and Operating. Foundation carries Certificates of Deposits (CDs), savings, and checking accounts. Foundation funds currently total \$213,529.40. Foundation exists to fund educational opportunities for GAPPA members. Operating accounts consist of two CDs and a checking account. Total current balance is \$642,172.71. These funds are used to manage the conferences and business expenses for the association. Taxes for both GAPPA entities have been filed. Tax exempt status is current until 2025. No questions from the floor.

4. Committee Reports:

a. Workshop Committee: Priti Bhatia

She will be beginning her service on the Workshop Committee as a new incoming GAPPA board member. She noted flyers were placed on table yesterday containing QR codes linking to a survey for members asking what kind of workshops will be most valuable to them and for Business Partners to indicate what types of workshops they can provide. More info to come once this information is assessed.

b. Membership Committee: Dale Hess & Fola Teru
Hess noted the three types of memberships and respective fees,
collected and tracked through APPA National. Currently, APPA shows

GAPPA having 20 Institutional members, 1 subscribing member, and 68 Business Partners. Teru noted she is new to the board and has a goal of increasing membership by speaking with Chief Business Officers about the value of GAPPA to the institutional members. Also with Technical Colleges.

c. Scholarship Committee: Laura Gay

Gay noted that GAPPA has reimbursed \$146,570.38 to members for educational opportunities. In 2023, \$13,500 among 6 members. In 2024 to date, 8 members have received a total of \$19,590.00. We currently have 18 open scholarship grant requests. \$27,000 is budgeted in 2024 for scholarships. Go to GAPPA.org/scholarships for more information. Applying is easy. She attested to 3 grants she has received and how they helped with her professional development.

Alan Poag, Emory University, took the podium and attested to GAPPA's help with the doctoral degree he is currently completing.

d. Website: Alan Sanderson

Sanderson noted he is a new board member, helping Sheree Srader with the website and other media. Talked about Cvent, Facebook, and Instagram accounts. Noted a GAPPA Group page where conference activity can be posted. Also have a new LinkedIn profile page where job postings can be shared for institutional members.
